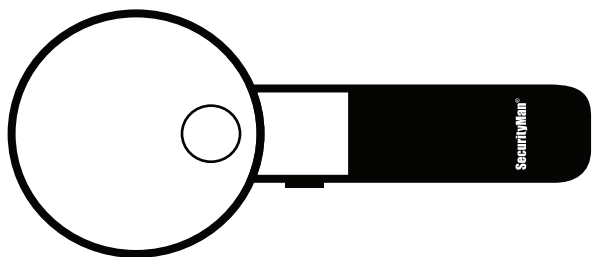


Handheld Magnifying Glass with Stand and 2 LEDs

Setup :

1. Use a small Philip screw driver, remove the battery cover and Insert the 2 AA batteries (included) as indicated by the polarity symbols (+ and -). Reattach the battery cover and secure the screw when done.

2. Once the battery cover is reattached, you can turn the LED light on and off using the on and off switch. Set the magnifier to a stands position by bending the handle backwards at the pivoting joint.
